

Rules and Regulations for using the charging station for electric and hybrid vehicles in the car park of Hotel AQUARIUS SPA**** in Kołobrzeg

§ 1.

- 1) The following Rules and Regulation ("Regulations") define the use of the Charging Station for electric and hybrid vehicles ("Charging Station") on the premises of the car park of the AQUARIUS SPA**** Hotel located in Kołobrzeg at ul. Kasprowicza 24 ("Car park").
- 2) The Regulations were established by PRO-SAN M. Jagiełka and M. Wiszniewski Sp. J., being the owner of the Hotel AQUARIUS SPA ***** ("Hotel"). The hotel reserves the right to amend the Regulations at any time without prior notice.
- 3) An electric vehicle is a passenger motor vehicle, according to Article 2, point 33 and 40 of The Act Of 20 June 1997, Road Traffic Law, that uses only electric energy accumulated by connecting to an external power source.
- 4) A hybrid vehicle is a passenger motor vehicle, according to Article 2, point 33 and 40 of The Act Of 20 June 1997, Road Traffic Law, that uses combustion and electric engine, in which electricity is accumulated by connecting to an external power source.
- 5) The Car Park has one marked Charging Station with two charging points, including the technical infrastructure and two dedicated places for electric or hybrid vehicles for the time of their charging.
- 6) The two dedicated places are the only ones intended for charging electric and hybrid vehicles. It is strictly forbidden to charge such vehicles using a 230V single-phase electrical system in the underground garage.
- 7) In the event of breach of the prohibition specified in the above mentioned section 6, the vehicle user is obliged to pay 100 PLN fee for each day of charging from a 230V single-phase electrical system.
- 8) The charging station has the status "Other than publicly accessible".
- 9) The places dedicated for the Charging Station are not considered as parking places and should be vacated immediately after completing the charging further occupation (blocking) is not







permitted. For the time of parking during charging, a parking fee should be paid in accordance with the applicable price list.

- 10) The Rules and Regulations apply to all persons using the Charging Station. Persons and vehicles that violate the provisions of the Rules and Regulations may be removed by the Hotel from the Charging Station at the expense of the vehicle user.
- 11) It is considered that any person driving a vehicle by entering the area of the Charging Station agrees to the provisions of the Rules and Regulations, undertakes to abide by them and is liable to the Hotel for non-compliance with the Rules and Regulations.

§ 2.

- 1) The use of the Charging Station is permitted 24 hours a day, on all days of the week.
- 2) The charging station is intended ONLY for charging electric or hybrid vehicles, therefore the places included in the charging station cannot be used for parking other vehicles. The above shall be without prejudice to the provisions of § 1 section 9.
- 3) Charging of the vehicle along with payment of the charges is done via the EV Plus mobile application. In exceptional circumstances, the Hotel may charge for using the Charging Station by a token card.
- 4) The Hotel may at any time prevent the use of the Charging Station by persons not using other Hotel services at the same time.

§ 3.

The basic rules for using the Charging Station include:

- 1) Use of the Charging Station only when charging an electric or hybrid vehicle,
- 2) Independent connection of the Charging Station plug to the electric or hybrid vehicle by the person driving the vehicle,
- 3) Absolutely no use of the Charging Station by:
 - a. vehicles transporting flammable, corrosive, explosive materials and other similar materials and substances that may pose a threat to people and property,







- b. vehicles serving as mobile shops, if their purpose would be to conduct commercial activities in the Car Park,
- c. combustion-powered vehicles,
- 4) Prohibition of leaving animals in the vehicle on the Charging Station premises,
- 5) Placement of an electric or hybrid vehicle at the Charging Station, immobilizing it, turning off the engine and the lights, closing the windows, doors and trunk,
- 6) Self-supervision of the vehicle by the person driving the vehicle against theft or burglary,
- 7) Leaving the plug of the Charging Station in the designated place after charging is completed.

§ 4.

- 1) Any interference with the technical infrastructure of the Charging Station is prohibited.
- 2) Any malfunctions of the Charging Station, as well as doubts about the use of the Charing Station must be reported to the Hotel reception immediately.

§ 5.

The hotel is not responsible:

- For any consequences of using the Charging Station in contrary to the following Rules and Regulations
- 2) For any interruptions in the operation of the Charging Station; each of the Charging Stations may be out of service at any time, either temporarily or permanently,
- 3) For any damage resulting from force majeure, theft (burglary, robbery, etc.), destruction or damage to vehicles located at the Charging Station premises, as well as items left in the vehicles or constituting their equipment.
- 4) For any consequences of actions of third parties.





§ 6.

- In the event of breaching the provisions of the following Rules and Regulations by the user, the Hotel may take measures necessary to restore the state in accordance with the Regulations, including:
 - a. charging an additional fee for each hour of occupying (blocking) a place dedicated to the Charging Station once the vehicle has been charged,
 - b. removing the vehicle from the Charging Station or applying a mechanical blockade to the vehicle.
- 2. In the circumstances specified in section 1, the user of the vehicle is obliged to pay a fee of PLN 50 for each hour of occupying (blocking) a place, and in the event of removing the vehicle from the Charging Station, securing and storing it until the vehicle is collected by the user to pay a fee of PLN 1,000.
- 3. The User is responsible for any damage caused by the vehicle or arising in connection with the use of the Charging Station.
